

# **Recognizing an Outstanding Entrepreneur**

## **Outstanding Entrepreneur Award**

A CFDC loan client which illustrates innovation in business practice, builds on the resources at hand, responds to changes, challenges and opportunities and demonstrates positive employment and economic outcomes in the community.

#### Nominations

Each CFDC completes one nomination form per nominee. The CFDC then submits nomination form by email (supplementary materials submitted electronically must be properly labeled, and in Word, Excel or PDF format).

All entries must be received by 4 :00 pm, Friday May 31, 2019.

## Selection process

Two independent judges, with no connection to Community Futures Ontario (CF Ontario) or the Community Futures Program in Ontario, will review the nominations and provide their selection to CF Ontario. Submission of a nomination form entitles CF Ontario to disclose nominees' names, business information and photos and video for promotion and marketing purposes. One winner will be determined.

## Winning Entry

The successful nominee will receive recognition at a special banquet and awards ceremony at CF Ontario's Annual Conference. A video presentation about the winning entrepreneur's business will be prepared for Awards Ceremony which will take place on **Monday, September 16**<sup>th</sup> at the London Convention Centre.

The winner will receive a crystal trophy as a memento of the occasion and a cash prize of \$350. During the Awards Ceremony, a video presentation will be shown about the business, with the winner receiving a copy on DVD. Transportation for two and one hotel room for one night will also be provided to the winner.
